**TERMS AND CONDITIONS FOR THE SALE OF SEASON TICKETS  
FOOTBALL SEASON 2026/2027**

1. Tickets for individual matches and season tickets for the matches covered by the season ticket (hereinafter referred to in the singular and plural as 'Tickets' or 'Season Ticket') are issued by "A.C. Milan S.p.A. (hereinafter referred to as ACMilan or the Club) with registered office in Milan, Via Aldo Rossi n.8, postcode 20149, telephone number 02.62281, email address [reception@acmilan.com](mailto:reception@acmilan.com), call centre +39 02.82958070.
2. The publication and offering for sale of any Tickets and/or Season Tickets shall not constitute an offer to the public capable of acceptance, pursuant to Article 1336 of the Italian Civil Code, but shall merely constitute an invitation to treat. AC Milan shall be under no obligation to proceed with the sale and reserves the right, at its sole discretion and for legitimate reasons, to determine, amend, suspend or withdraw, in whole or in part, the availability of any Tickets, without thereby giving rise to any right to purchase, any legally protected expectation or any pre-contractual liability on the part of AC Milan. Tickets may only be purchased through the official channels of ACMilan, listed on the website [www.acmilan.com](http://www.acmilan.com), in accordance with the methods of issue indicated in the dedicated section. In the case of purchases via the internet, these may only be made through authorised websites and in compliance with the procedures established by AC Milan and any restrictions imposed by the authorities. The Club shall NOT BE LIABLE for any loss or damage suffered by Holders of Tickets purchased through channels other than those authorised. The purchase of a Ticket implies acceptance of and compliance with these Terms and Conditions of Sale, the 'Regulations for Use of the San Siro Stadium' and the Code of Conduct and Regulations applied by ACMilan. The Ticket shall be cancelled or otherwise rendered unusable if the Holder or his/her name is not authorised to access the sports facilities as a result of criminal or administrative measures, or if it is used by a person other than the Holder or in the event of violations of the 'Stadium Regulations' published on the website [www.acmilan.com](http://www.acmilan.com) and posted at the "G. Meazza San Siro Stadium" or of the Code of Conduct and Regulations published on the website [www.acmilan.com](http://www.acmilan.com).
3. The "Classic" Season Ticket entitles the holder to admission to the Stadium for home League Matches only and to four (4) Ticket Name Changes during the Football Season, one per Match, while the "Plus" Season Ticket entitles the holder to admission to the Stadium for home League Matches, the four (4) home Matches in the UEFA Europa League Phase and the first home Match in the Coppa Italia, as well as to a total of twelve (12) Ticket Name Changes during the Football Season, one per Match.
4. The Tickets are assigned by name and entitle the holder (hereinafter, singular and plural: the Holder) to watch (solely in the sector, row and seat indicated on the Ticket) the home matches of the First Team of AC Milan in the assigned seat for the competitions to which the Ticket refers, in accordance with the calendar of LNPA (including early and late kick-offs) - date, time, and place - established by the organizer of the competition, including any variation, whatever their cause. Access to the Stadium is also subject to the presentation of the documentation and certifications required from time to time by the orders issued by the competent authorities. In the event of failure to present the documentation mentioned above, access to the Stadium will not be permitted. The possible absence of separation barriers between the various sectors does not allow the Holder to sit in a different place from that indicated on the Ticket. Personnel on duty at the Stadium during the matches is entitled to verify the matching of the Ticket with the seat occupied by the Holder and to send the latter away from the Stadium should he/she be sitting in a different place from that printed on the Ticket. The Holder therefore undertakes: **(a)** not to allow under any circumstances the use of the Ticket by persons who are prohibited from entering sports facilities (and/or purchasing the relevant tickets); **(b)** not to use the Ticket for commercial purposes, speculation and/or ticket touting; **(c)** not resell the seat or transfer their Ticket to third parties, including through online sales platforms that carry out secondary ticketing activities (including offers of Tickets as part of an offer of complementary services and/or products, even within heterogeneous packages for individual events), except in cases expressly provided for and authorised by ACMilan.
5. During the Football Season, Milan reserves the right, at its sole discretion, to activate the "Resale Platform", available at <https://booking.acmilan.com/rivendi-abbonamento/> (the "**Resale Platform**"), through which the Holder may initiate the procedure for listing for sale the individual Match entitlement under the Season Ticket relating to a specific Match (the "**Sale Procedure**").

Milan further reserves the right to determine, from time to time, including in respect of one or more specific Matches, whether access to the Resale Platform shall be available to Holders of Classic and Plus Season Tickets or exclusively to Holders of Plus Season Tickets, and shall give notice thereof by such means as Milan, at its discretion, deems appropriate. The Resale Platform shall be active from the date specified by Milan from time to time and, unless otherwise indicated, shall remain accessible until 48 (forty-eight) hours before the start of the Match to which the Ticket that is the subject of the Sale Procedure grants admission. The Sale Procedure shall be available from the date communicated by Milan from time to time and may not be withdrawn for a period of 48 (forty-eight) hours following its activation (the "**Blocking Period**"). Use of the Resale Platform shall be governed by the relevant General Terms and Conditions, which must be accepted by the user as a condition of using the Resale Platform. If Milan successfully sells the Ticket, the Holder shall be granted a credit equal to 60% (sixty per cent) of the price at which Milan sold the relevant Ticket (the "**Resale Credit**" and, collectively, the "**Resale Credits**"). It is understood that, following completion by the Holder of the activation stage of the Sale Procedure, Milan shall be obliged solely to relist for sale, as soon as reasonably practicable and without any obligation to do so simultaneously with the completion of such activation stage, the Ticket that is the subject of the Sale Procedure through the Resale Platform, without in any circumstances guaranteeing that the Ticket will actually be sold. It is further understood that, if the Ticket has not been sold within 48 (forty-eight) hours of the start of the Match, the relevant Ticket shall become available to the Holder again and may, at the Holder's discretion, be used to attend the Match to which it grants admission, without the Holder accruing any Resale Credit.

6. Season tickets in the Second Green Tier for the Milan-Inter match (derby) may be moved at no additional cost to the Third Blue Tier or Third Red Tier, at the sole discretion of AC Milan based on availability, or alternatively, the season ticket holder may purchase a ticket at a reduced price in any sector of the stadium of their choice from among the seats available in the manner and within the time limits to be communicated by AC Milan.
7. The Holder is the custodian of the Ticket entrusted to them and is responsible for all consequences arising from its use by third parties. The risks of loss, destruction or theft are the sole responsibility of the Ticket Holder. In the event of loss, theft or destruction of the Ticket, no duplicate ticket will be issued, nor will the Ticket Holder be entitled to any refund or replacement ticket.
8. Any changes to the fixtures, with consequent modification of the date and/or time of the matches must be considered usual and must therefore be considered by the Holder when purchasing the Tickets. Variations outside the LNPA and/or UEFA match calendar date (including, for this purpose, any early or postponed fixtures), as determined from time to time by the competition organiser, including any change made by the organiser will only entitle the Holder to a refund of the price of the Season Ticket portion (1/19 of the value of the "Classic" Season Ticket or 1/24 of the value of the "Plus" Season Ticket), subject to the correct and complete completion of the refund procedure indicated, from time to time, on the website [www.acmilan.com](http://www.acmilan.com). On the other hand, compensation for damages, as well as the reimbursement of any expenses, of whatever nature, incurred by the Holder as a result of the aforementioned variation is excluded except in the event that such variation is directly caused by AC Milan's wilful or negligent conduct, and in any event any right to compensation for damages and/or reimbursement of any expenses incurred is deemed excluded whenever such variation: (i) results from a request received to that effect from the organizer of the competition and/or (ii) is arranged by AC Milan in implementation of an order or measure of the sports, administrative or public authorities.
9. The Ticket may be transferred only for the number of Matches specified in Article 3 above and to one (1) person only in respect of each individual Match. AC Milan reserves the right to charge a fee for the Ticket Name Change procedure in respect of individual Matches. The Ticket may be transferred only for the number of Matches specified for the Season Ticket purchased through the name change procedure (the '**Name Change**') available online at [www.acmilan.com](http://www.acmilan.com). Where the transfer of the Ticket is permitted: **(a)** the Name Change procedure may only be carried out in favour of a person who holds a "CRN Card" and is entitled to the same rights. It is not possible to request a Name Change in order to upgrade from a reduced to a full price ticket, or to change seats; **(b)** the Name Change is only valid for the selected match and is in any case subject to any restrictions imposed by the public security authorities or other public authorities; and **(c)** it is mandatory to follow the instructions provided in the email confirming the Name Change. Upon admission to the Stadium, the transferee must present their CRN Card together with the receipt issued via [www.acmilan.com](http://www.acmilan.com) confirming that the Ticket Name Change has been completed. Under no circumstances shall a Ticket Name Change be permitted in favour of any person who



- has been sanctioned by the Supervisory Commission. The right to transfer to third parties the Tickets relevant to the Season tickets purchased is in any case subject to:
- the limits imposed by AC Milan, at its discretion, during the season and could therefore also be fully prohibited
  - any limit imposed by the competent administrative Authorities.
10. Tickets for access to the 2nd blue tier will under no circumstances be transferable.
  11. AC Milan may, at its sole discretion, grant Classic Season Ticket Holders a priority right to purchase their usual seat, within the time limits and subject to the terms and conditions communicated by AC Milan from time to time, for competitive Matches not included in the Season Ticket (such as, for example, Coppa Italia and UEFA Europa League Matches). In accordance with UEFA regulations, for UEFA Champions League and UEFA Europa League Matches, no priority right to purchase the usual seat may be granted in respect of seats located in sectors reserved by UEFA, which shall be notified to the public from time to time. In the case of Coppa Italia Matches, the period during which the priority purchase right may be exercised may be guaranteed only insofar as this is compatible with the provisions communicated from time to time by Lega Calcio, the FIGC and any other Competent Bodies or Authorities. AC Milan cannot therefore guarantee the availability of all sectors. Where a priority purchase right is granted, AC Milan shall inform eligible Season Ticket Holders via [www.acmilan.com](http://www.acmilan.com).
  12. AC Milan may, at its sole discretion, grant Plus Season Ticket Holders a priority right to purchase Tickets for away Matches played by AC Milan's men's first team in UEFA Competitions (excluding any final). In view of the applicable UEFA regulations, where a priority sale period is granted, AC Milan shall inform eligible Season Ticket Holders via [www.acmilan.com](http://www.acmilan.com).
  13. AC Milan may, at its sole discretion, grant Classic and Plus Season Ticket Holders access to a priority sale period for the purchase of Tickets for individual Matches in respect of all home Matches played by AC Milan's men's first team, within the time limits and in accordance with the procedures communicated by AC Milan. Where a priority sale period is granted, AC Milan shall inform eligible Season Ticket Holders via [www.acmilan.com](http://www.acmilan.com).
  14. Any abuse and/or fraudulent use of the Ticket will result in its immediate withdrawal and/or blocking. The Ticket may be withdrawn, cancelled, blocked or its use temporarily or permanently prohibited at any time in the cases provided for by law and these Terms and Conditions. By way of example and without limitation, the following shall be considered abuse within the meaning of the above:
    - (a) failure to pay, in whole or in part, or fraudulent payment of the Season Ticket (e.g. payment by or to an unauthorised person);
    - (b) use of the Season Ticket for counterfeiting purposes or the issue of unauthorised duplicates;
    - (c) access or attempted access to a sector other than that indicated in the Season Ticket, unless expressly authorised by AC Milan;
    - (d) use or attempted use of a single Season Ticket by more than one person;
    - (e) the untruthfulness or incompleteness of the data provided when subscribing to the Season Ticket;
    - (f) purchasing the Season Ticket (or any ticket for access to the Stadium) from retailers not authorised by AC Milan; and/o
    - (g) purchasing the Season Ticket (or any ticket for access to the Stadium) while subject to a sanction imposed by AC Milan which, at the time of purchase of the Season Ticket, prohibited the Holder from purchasing it.
  15. AC Milan also reserves the unquestionable right to withdraw and/or block the Ticket in the event of: (a) unlawful behaviour, contrary to the law, public order or morality; (b) acts of violence and/or racism, in any form and/or expression, against persons and/or property; (c) any administrative or judicial measure prohibiting access to stadiums, banning and/or removing season ticket holders from stadiums; (d) any other restrictive measure imposed by any authority that in any way prohibits the season ticket holder from attending meetings open to the public; (e) standing along the sorting routes, stairs and emergency exits or any other behaviour aimed in any way at impeding the movement of spectators and security personnel, as well as the proper evacuation of those present; (f) bringing explosive materials, weapons, or objects that could cause injury, bottles, cans, and other blunt and/or dangerous objects into the Stadium; (g) any and all behaviour that may be considered, at the sole discretion of AC Milan, to be evasive or contrary to the Conditions, the Code of Conduct, and the Stadium Regulations.

16. The Holder acknowledges and expressly accepts that A.C. Milan, in compliance with the Code of Conduct, may carry out investigations and checks on him/her in order to prevent and punish certain conduct prohibited by the Code of Conduct itself. Furthermore, the Holder expressly acknowledges and accepts that the sanctions provided for in the Code of Conduct may consist, by way of example and without limitation, expulsion from matches in progress and/or a ban on purchasing tickets and season tickets or using tickets and season tickets already purchased (without any right to a refund), for up to a maximum of five sporting seasons, in accordance with the terms and procedures set out in the Code of Conduct. The Code of Conduct, in its current version, is available at [www.acmilan.com](http://www.acmilan.com).
17. In the cases provided for in Articles 14, 15 and 16 above, AC Milan shall be entitled to retain the amount paid for the Ticket for the matches not attended as a penalty.
18. AC Milan reserves the right to provide a "dress code" for the access to some Hospitality areas of the Stadium and reserves the right to accommodate its guests in rooms other than those planned and/or to offer an alternative food and beverage service to the one initially communicated, in case of temporary unavailability of a Hospitality area or the service previously agreed upon.
19. The right of access cannot be exercised in the rescheduled match of a match suspended after the kick-off of the second half.
20. Considering that the seats in the second and third tiers are not easily accessible, the purchase of Tickets in these areas is discouraged for people with confirmed walking difficulties. AC Milan reserves the right to evaluate walking ability in relation to public safety requirements and deny access where discouraged by community interests. This is without prejudice to the Holder's right to make change ticket user procedure in the terms and manner indicated from time to time on [www.acmilan.com](http://www.acmilan.com). People who require a wheelchair to walk will only have access to certain areas, as it is impossible to reach all areas of the stadium due to its structure.
21. In cases of disqualification of the pitch with the match being played in another stadium, or the obligation to play the matches behind closed doors, or the reduction of the capacity of the Stadium, the Holder - provided that he/she has not contributed to causing the liability, including objective liability (as qualified by the Code of Sports Justice of the Federazione Italiana Giuoco Calcio) of AC Milan as a result of which it was decided that the match be played in another stadium or behind closed doors or with reduced capacity - shall have the right to request the refund of the season ticket portion upon proper and complete completion of the refund procedure indicated, from time to time, on the website [www.acmilan.com](http://www.acmilan.com). The right to a refund under this Article 10 is excluded if AC Milan provides the season ticket holder with a replacement coupon to attend the match in another sector of the Stadium. In the event that the match is played in another stadium, the season ticket holder, as an alternative to obtaining a refund as provided for in the previous paragraph, may ask AC Milan, subject to the correct and complete completion of the procedure indicated from time to time on the website [www.acmilan.com](http://www.acmilan.com), a replacement ticket valid as a Ticket for admission to the stadium where the match will be played, and the request will be satisfied subject to the seating capacity of the different stadium identified for the match. In any case, compensation for damages resulting from the change of stadium or the match being played behind closed doors is excluded, except in the event that the match is played in another stadium or behind closed doors as a direct result of wilful misconduct or negligence on the part of AC Milan, and in any case excluding any right to compensation for damages whenever the change of stadium or the match being played behind closed doors is the result of compliance with legal provisions, regulations or other acts or measures of administrative, public or sporting authorities (including sports justice bodies).
22. AC Milan over the course of the season reserves the right to offer limited-number packages, including Tickets for more matches.
23. Access to the Stadium is subject to the exhibition of a proper documentation proving the right to receive the ticket at a reduced price or free of charge. The Stadium personnel are entitled to request the exhibition of the documentation and to verify its suitability at any time, either at the entrance or inside the Stadium. Access to the Stadium shall not be granted if the aforementioned documentation is not produced or is invalid. Furthermore, the Holder may be expelled if identified inside the Stadium without the appropriate documentation.
24. AC Milan has the right to create a price list subject to dynamic increases, according to the availability of Tickets and sectors, depending on the time of purchase of the Tickets.

25. Minors under the age of 14 may enter the Stadium only if accompanied by adults, each holding a regular Ticket
26. Please note that the personal data needed for the purchase of Tickets for access to the Stadium will be processed by AC Milan, as data controller, pursuant to EU Regulation no. 679/2016 and Legislative Decree no. 196/2003, for the purposes and in the manners described in the privacy policy provided when subscribing to CRN card and / or in any case available on the website [www.acmilan.com](http://www.acmilan.com). The consents granted on other occasions are valid limited to the processing carried out by AC Milan and subject to the express consent.
27. Pursuant to Article 59(n), of Legislative Decree No. 21/2014, Tickets, even if purchased off-premises, do not enjoy the right of withdrawal referred to in Article 52 of the same law, because they relate to services concerning leisure activities that provide for a specific date or period of performance.
28. AC Milan may assign a seat other than the one indicated on the Ticket for reasons of force majeure, fortuitous event, public order, security, maintenance and/or modernization work or on the instructions of Public Safety Authorities, Lega Nazionale Professionisti, Observatory, CASMS or any other competent body. In such a case, the assigned seat will be a seat for which the full purchase price of the relevant Ticket is equal to or greater than that purchased.
29. Please note that the squad may undergo significant changes during the football season. The use of the image of the players part of the squad for promotional purposes in the context of the season ticket campaign does not constitute a guarantee of their stay in the team.
